MUSICIANSHIP STUDIES – EXEMPTION CRITERIA

- (d) Students sitting the Junior Certificate or Leaving Certificate examinations in the given academic session.

All claims for exemption **must be applied for on an Exemption Claim Form**

and must be approved by the Musicianship Co-Ordinator on or before the beginning of the academic year.

The final closing date for receipt of forms, within an academic session, is 31st October. No forms will be accepted after this date.
